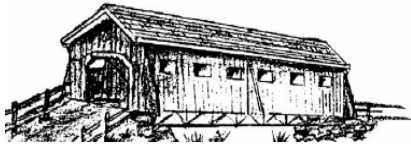

### ***2012 WEEKEND GOLFER***

#### **GUIDELINES AND RESTRICTIONS:**

- May play **ONLY** Saturday and Sunday after 12:00PM
- Tee times are required, and can be made up to 5 days in advance. NOTE: Availability may be affected by certain Club functions (Member/Guest, outside tournaments, etc). Players must check in at Pro Shop before starting play.
- Dress code is in effect, proper golf etiquette will be expected. (Playing privileges may be revoked if OCC requirements are not adhered to.)
- No play will be allowed in OCC leagues, tournaments, stag days, etc., except as a guest of a regular member, subject to the "5 times per year" rule. However, Weekend Golfers may be eligible to play in events scheduled for Saturday or Sunday afternoon.
- Carts may be charged to your account number.
- NO food / cart assessment required.
- NO Stock purchase required.
- Anyone currently in arrears or suspended from the Club is not eligible.
- This category will be evaluated yearly and may not be offered every year.

***\*Available on an individual case review basis, and is not intended to be available to regular members. Current social accounts may upgrade to the weekend golfer category.***
